<b>FREQUENCIES</b>	
Routine Exams	2 times per plan year - anytime
Cleaning	2 times per plan year - anytime
Fluoride	2 times per plan year - anytime, up to age 15
Bitewing X-rays	2 times per plan year - anytime
Periapical X-rays	6 per plan year
Panoramic or Full Mouth X-ray	1 per 36 months
Filling Replacement	Once per 24 months
Major Replacement	Once per 5 years
